Subject: On-Line Access to Project Account Statements

You are now able to access your Research Foundation project account statements on-line. Many Principal Investigators have requested the ability to have on-line access to their project account information. CANOPY software provides user-friendly access to your account information in FAMIS. The account information is updated on a real-time basis. You will need a FAMIS logon identification to access your project account information. Attached are instructions explaining how to access your account information if you already have a FAMIS logon identification or how to get a FAMIS logon identification if do not already have one.

- Follow the instructions under PART A, if you currently access your accounts in campus code 99 (TAMRF).
- Follow the instructions under PART B, if you have a FAMIS logon identification, but you do not have access to campus code 99 (TAMRF).
- Follow the instructions under PART C, if you do not have a FAMIS logon identification.

PART A

If you can currently access your accounts in campus code 99 (TAMRF), you can also access your accounts through CANOPY.

1. Go to <https://sago-apps.tamu.edu/canopy/logon.aspx?c=1>
2. Type in your FAMIS ID and password
3. Select Campus Code 99-Texas A&M Research Foundation
4. Select Set CC/FY
5. Select Account Inquiry (FRS)

There are many search options available and the data can be presented in several different formats.
